5. Commercial Law

The Japan Association of Private Law held a symposium in 1979 on the theme "Liability of Company Directors and Officers." Discussions were held on the following reports entered at the symposium:

The symposium, mindful of the prevailing trends and the work of the amendment of the business corporation law now under way, has made efforts to clarify various important problems centering on the liabilities of company directors.
