The 1984 general meeting of the Association of Economic Jurisprudence was held at Komazawa University on Oct. 12, 1984. The association held a symposium on the theme of "International Transfer of Technology and the Law". ## 6. Labor Law

The main activities of the Japan Labor Law Association in 1984 were two symposia and the completion of the Modern Labor Law Series (15 volumes). In the symposia, effective protection measures for part-time employees and problems of the Equal Employment Opportunity Bill reflected in the extreme changes in employment and labor practices in Japan were discus-

sed. These are introduced below.

- 1. The 67th general meeting of the association held at Ryukoku University in Kyoto on May 10, 1984, under the general theme of "Legal Protection of Part-Time Workers". Individual Reports
- (1) "Legal Protection of Part-Time Workers," by Takashi Shimoi, Professor of Kobe University.

  Discussions were lively in connection with ratification of the Convention on the Elimination of All Forms of Discrimination

against Women and the Equal Employment Opportunity Bill proposed by the Ministry of Labor. The most lively discussion was on whether and how men and women could work on equal terms under the present circumstances of "abnormally" long working hours, high-density work and the deep-rooted sense of discrimination between men and women. Whether to make women work like men (it may be directly connected to destruction of maternity and home life) or make men work like women was the main subject of the discussions.
