fective. Due to the tendency, this revision was made in order (1) to secure working conditions, (2) to rationalize dispatched employment, (3) to simplify procedures, and (4) to extend the covered occupations. For the past ten years, worker-dispatching undertakings have increased in work which is temporary and does not require special knowledge, technique or experience, as well as work which requires them. According to the change of functions, occupations covered by the Law have been gradually extended as in item (4) of this revision.
